# BACKDROP

Vide MoEF&CC Order No. F. No. 16-1/2022-RT dt. 22<sup>nd</sup> October 2022, Indian Plywood Industries Research and Training Institute (IPIRTI), Bengaluru has been merged with Institute of Wood Science and Technology (IWST), Bengaluru. Erstwhile IPIRTI was an autonomous body of Ministry of Environment, Forests and Climate Change (MoEF&CC), Govt. of India and the IPIRTI Society was registered under Karnataka Registration Act 1960 and the same has been dissolved as per Para 3 of the aforementioned merger Order . As was decided in the 57<sup>th</sup> Annual General Meeting (AGM) of IPIRTI Society, all the members of IPIRTI Society can be a part of the Advisory Board for the merged Institutes.

In view of the same, Director General, Indian Council of Forestry Research and Education, Dehra Dun has constituted an advisory committee with the name “ICFRE-Wood Industries Committee of India (ICFRE-WINCOIN)” for extending its membership to the Industries for continuation of the platform for the wood based industries to contribute in the Research, Training and Testing requirements of the wood-based industries in the country.

# SCOPE & COMPOSITION OF ICFRE-WINCOIN

## Scope

- To bring together all the wood-based industries (e.g. Solid wood, furniture, handicrafts, etc.) and allied industries associated with wood products in the proposed committee.
- The ICFRE-WINCOIN shall meet annually to invite suggestions of the industries and to take up the issues for their commensurate solutions.
- The membership fee structure is proposed to be kept same as it was for erstwhile IPIRTI Society Membership. However, it can be reviewed once in every two years.

Any wood based industry/association/relevant stakeholder may become a new member or renew membership by applying to relevant category by submitting an application form as per following details :

Details of Membership Type (Category) and Membership fees are as under:

Membership Category	Membership Fee
<b>(i) Life Membership SSI:</b>	(i) Rs.1,20,000/- + 18% GST (In one lumpsum or in 4 instalments of Rs.30,000+18%GST payable half-yearly)
<b>(ii) Life Membership MSI/LSI:</b>	(ii) Rs.2,40,000/- + 18% GST (In one lumpsum or in 4 instalments of Rs.60000+18%GST payable half-yearly)
<b>(iii) Annual Member SSI</b>	(iii) Rs.12,000 + 18% GST for Small Scale Industries / units
<b>(iv) Annual Member MSI/LSI:</b> Manufacturers of panels from wood and other lignocellulosic materials	(iii) Rs.24,000 + 18% GST for 1" year and thereafter for renewal Rs.18,000+ 18% GST every year for Medium/ Large Scale Industries / Units
<b>Associate Member:</b> Other manufacturers like machinery, resins and chemicals etc	Rs. 6000/- per year +18% GST
