- 4. In case of equal marks/ tie up marks in the written examination, the merit will be decided based on the ranking in the various subsections in progressive order. For example, Sub section (i) will have higher priority than sub section (ii) and so on. In the event of all equality, older candidates shall be placed at higher merit as per their Date of Birth.
